#### **Planning Commission**

The Planning Commission fulfills duties prescribed under State law and consistent with policies established by the Suisun City Council. The Commission reviews and makes recommendations on the community's General Plan, development applications and policy proposals on both current development, as well as long range plans for future development. Planning Commission meetings are held on the second and fourth Tuesdays of the month at 6:30 p.m., in the Council Chambers at Suisun City Hall.

#### **Housing Authority of the City of Suisun City – Tenant Commissioner**

The Housing Authority Commission is the governing board of the Housing Authority and consists of the Mayor, City Council and two Tenant Commissioners. Applicants for Tenant Commissioner appointment must be a tenant of the Housing Authority. Tenant Commissioners are appointed for a term of two years, vacancies shall be filled for the unexpired term. Regular meetings of the Housing Authority are held on the first Tuesday of January, April, July, October; however, every Tuesday shall be considered a regular meeting day if necessary to carry out the business of the Housing Authority.
